1. It is agreed that the client will pay one hundred dollars of the total amount upon the signing of this contract. The balance is to be paid on or before the day of the above described event. No payments are to be made after the event.
2. We apologize for any inconvenience but, our videographers will be assigned to the weddings as the dates get closer. It is difficult to know where our videographers will be assigned when we are taking bookings a year in advance. We require approximately ninety days to edit and complete a wedding.
3. In the event of postponement or cancellation of the assignment, A to Z Video Productions may retain part or all of the deposits unless written notification is received by A to Z Video Productions at least six months prior to the date of the assignment. If the wedding is cancelled within six months of the wedding day, A to Z Video Productions will retain all deposits and require payment in full upon cancellation.
4. A to Z Video Productions takes utmost care with respect to the terms of this contract. However, due to any event beyond our control, this company's liability is limited to the refund of all deposits in cases which refunds are agreed upon by both parties. "Beyond our control" includes, but is not limited to: weather related problems, traffic, roadway delays, automobile failure or emergencies of any nature.
5. Although A to Z Video Productions maintains their equipment to the highest degree, we can not be held responsible for equipment failure or weather related problems including but not limited to: moisture, dew, fogged lenses, humidity problems or videotape defects. In the event problems do occur, A to Z Video Productions and you, the client, will develop a solution to be agreed upon by both parties.
6. Once the video is completed, no changes will be made. If you, the client, require changes, a cost of \$150.00 per hour will be billed to you.
7. Please put all photos for the photo montage in order and number the backs. Use a felt tip, quick dry marker that does not bleed through paper. Send them to us about one month before your wedding date. If photos are sent to us after the wedding, no time can be given for the finished product.
8. Please feed the videographers. They work better on a full stomach.
